6. BUSINESS

a. New and Potential Members

- i. Mount Prospect and Waukegan There were issues that temporarily delayed the go live but both libraries are now live on the system. The project review is in progress. The post go-live survey is now open for libraries to complete and a memo will be sent to library directors by the end of the month. CCS continues to troubleshoot issues with Innovative and is holding off on loading the libraries' Overdrive records until system issues can be resolved.
- ii. Potential New Members R. Malinowski met with D. Archer at Cook Memorial to discuss CCS. CCS is also speaking with Wauconda staff regarding Polaris and potential long-term options.

b. Innovative Updates -

- i. System Patch Applied R. Malinowski reported that the 7.6 upgrade in August has created new system performance issues. Details of the system issues were noted in the packet. A patch was installed by Innovative on October 9 and there have been no issues reported since the patch was installed. Innovative is monitoring the system and R. Barth has set up internal email alerts for CCS staff. CCS is working with the Polaris development team to discuss how to ensure future upgrades do not impact the system or allow for testing prior to the upgrade.
- c. Find More Illinois D. Wischmeyer reported that twenty-six libraries are now live on Find More Illinois with Highland Park and Northbrook scheduled to go live in January 2025. There are still outstanding issues being worked on by RAILS and AutoGraphics primarily related to a recent SHAREit upgrade that introduced a new bug. A fix was implemented on October 15 with a software rollout and D. Wischmeyer will follow up with libraries to see if this fix resolved the issue.
- d. Member Services Recruiting D. Wischmeyer reported that CCS continues to work with HR Source to fill the open Member Services Associate position with V. Seward's upcoming retirement. There have been over ninety applicants so far, mostly through RAILS and Indeed. CCS hopes to have a new hire start the first or second week of December.
